Case # 2014-002042


I, Sharlene Oyao, voluntarily surrender Alaska Board of Pharmacy license #3897, which was first issued to me on April 10, 2012 and has an expiration date of June 30, 2016.

I am permanently surrendering my license at this time with the understanding that the Division of Corporations, Business and Professional Licensing has an open investigation under case number 2014-002042 on behalf of the Alaska State Board of Pharmacy (Board), concerning a criminal indictment filed against me on August 21, 2014. The charges are felony offenses which is in violation of 8.80.261(a)(4). The charges are related to my taking Hydrocodone pills, Vicodin pills, Alprozolam pills, Suboxone sublingual film and Promethazine-Codeine syrup from February to July 2014, which I admitted I took and later sold to individuals for personal use.

An audit of the pharmacy later revealed that 2,634 Hydrocodone, 100 Vicodin, 3100 Alprazolam, 120 Suboxone and 24 bottles of Promethazine-Codeine syrup were missing from the pharmacy during that same time.

I understand as a result of this surrender, I cannot practice as a Pharmacist Technician in the State of Alaska and will not be able to do so until I have the approval of the Alaska State Board of Pharmacy.

I am surrendering my license of my own free will and no promises or threats have been made to me by anyone to make me sign this document.
