IMPOSITION OF CIVIL FINE



Unicare Pharmacy, Inc DBA as MedicoRx Specialty, admit and agree that the Alaska Board of Pharmacy (Board) has jurisdiction over the subject matter of our application for licensure in Alaska and over this Imposition of Civil Fine.

1. On December 4, 2014, Unicare Pharmacy, Inc DBA as MedicoRx Specialty applied for an Out of State Pharmacy license in Alaska.
2. MedicoRx Specialty withheld information from their initial application to the Board regarding a 2012 citation and fine issued by the California Board of Pharmacy.
3. MedicoRx Specialty stated that they did not intend to deceive the Board and that this was a miscommunication, since the 2012 citation involved an alternate pharmacy location, not related to this licensing request.

MedicoRx Specialty admits that as a result of these facts, grounds exist for possible denial of licensure pursuant to AS 08.01.075, and AS 08.80.261(a)(1). MedicoRx Specialty is agreeing to the Imposition of a Civil Fine of \$500.00 in cash, certified check, or money order payable to the "State of Alaska" within ninety (90) days after this Imposition of Civil Fine is accepted by the Board.

MedicoRx Specialty have the right to consult with an attorney and MedicoRx Specialty have a right to an administrative hearing on the facts in this case. MedicoRx Specialty understands and agrees that by voluntarily signing this Imposition of Civil Fine, MedicoRx Specialty is waiving their rights to counsel and to a hearing on this matter.
