SURRENDER OF LICENSE

Case Number 2017-000919

I, Zoe A. Stuckey, surrender my Alaska Pharmacy Technician license# PHAC2110, which was first issued to me on November 9, 2006, and will lapse unless renewed on June 30, 2018.

I am permanently surrendering my above license at this time with the understanding that under Case #2017-000919, the Division of Corporation, Business and Professional licensing, on behalf Alaska Board of Pharmacy (Board), investigated my June 28, 2016 diversion and theft of one-hundred (100) acetaminophen with codeine tablets (300mg/60mg) while I was employed as Pharmacy Technician.

I was subsequently charged with Misconduct Involving a Controlled Substance in the Fourth Degree (Class A Misdemeanor) and Theft in the Fourth Degree (less than \$250) (Class B Misdemeanor), under Alaska Court Case # 3AN17-05105CR. On June 29, 2017, I plead guilty to Misconduct Involving a Controlled Substance in the Fourth Degree (Class A Misdemeanor) for the possession of a controlled substance / acetaminophen with codeine tablets (300mg/60mg).

I acknowledge the above action provide grounds for suspension, revocation or other disciplinary sanctions of my license pursuant to Alaska Statute (AS) 08.01.075, AS 08.80.261(a)(2), (a)(11) and 12 AAC 52.920(a)(4).

I understand that as a result of this license surrender, I cannot practice as Pharmacy Technician in the State of Alaska, and will not be able to do so until I have the approval of the Board. I further understand that before my license to practice as a Pharmacy Technician in Alaska can be reinstated, I will have to demonstrate to the Board that I am competent to resume practice, and am able to do so with skill and safety. If I make such request for reinstatement, and the Board denies me, I have the right to a Hearing, pursuant to AS 44.62, of the Administrative Procedure Act.

I am surrendering my license of my own free will. I am not under the influence of any medicine or other drugs that would affect my ability to think clearly and rationally. No promises or threats have been made to me by anyone to make me sign this document.
