School License Application Instructions

Please read the instructions before completing the application. Emailed applications will not be accepted.

A person, association, firm, or corporation proposing to open a school of barbering, non-chemical barbering, hair braiding, hairdressing, esthetics, or manicuring shall apply to the board for a school license on a form provided by the department

The following must be received by the division before your application for School License can be reviewed:

1. APPLICATION

A completed application, signed and notarized (#08-4190, pages 1-3).

2. FEES

Fees made payable to "State of Alaska" in accordance with 12 AAC 02.140.

3. NAME OF OWNER(S)

Names of all school owners.

4. NAMES OF ALL PARTIES WITH FINANCIAL INTEREST

Names of all parties having a financial interest in the school, including all individuals, partners and incorporators.

5. CERTIFICATE OF REGISTRATION

A current and valid certificate of registration for the school issued by the Alaska Commission on Postsecondary Education <u>or</u> a letter from postsecondary education stating that a certificate will be issued upon the Board's approval for licensure <u>or</u> verification from postsecondary education that your school is exempt under AS 14.48.030.

6. DESCRIPTION OF FLOOR PLAN AND LOCATION

An exact description of the floor plan and location of school. This documentation should be submitted with the application on an 8" x 11" piece of paper; the plan may be hand drawn or a copy of the architectural plans. However, the document must include square footage and instructional areas.

Note: In order to be approved by the Board, a school shall provide at least 1,000 square feet, including at least 15 square feet of instructional areas per student. For minimum required instructional areas, please refer to 12 AAC 09.125. See 12 AAC 09.125(i) and (j) for square footage for schools of manicuring.

7. LIST OF EQUIPMENT AND SUPPLIES

A list of equipment and supplies per 12 AAC 09.155 for barbers, non-chemical barbers and hairdressers; 12 AAC 09.162 for estheticians; and 12 AAC 09.146 for advanced manicuring.

8. CERTIFICATE OF COMPLIANCE

For schools that will be teaching hairdressing, barbering, non-chemical barbering, advanced manicuring, esthetics or hair braiding: Original signed and notarized Certification of Compliance with 18 AAC 23 certifying that the owner and the school comply with the Alaska department of Environmental Conservation's sanitary health requirements outlined in 18 AAC 23. The booklet can be found on the Board's web page at *ProfessionalLicense.Alaska.Gov/BoardOfBarbersHairdressers*.

Please review pages 1-11 of the booklet and confirm that you are in compliance with the regulations by submitting the signed and notarized certification page included in the application (form #08-4190d). Facilities must still meet local city/municipality requirements.

When the application is complete, the school must be inspected by a member of the Board of Barbers and Hairdressers. Upon completion of the board member's review, the application and supporting documentation will be reviewed by the entire board and a license issued once approved.

A branch or extension of a licensed barber or hairdresser school is required to be in compliance with 12 AAC 09.125(b) – (d) and with 12 AAC 09.155 and 12 AAC 09.175. A branch or extension of a licensed manicuring or esthetics school is required to be in compliance with 12 AAC 09.125(b) – (d), and with 12 AAC 09.162 and 12 AAC 09.175.

A school license is not transferable to another person. In the event of sale, lease, or transfer of ownership of a school, the seller, lessor, or transferor shall notify the Board in writing of the transaction within 30 days after the sale, lease, or transfer. The notice must include the name and address of the buyer, lessee, or transferee. The buyer, lessee, or transferee must apply for and be issued a new school license before conducting business.

If the operation of a school is moved to a new location, the school owner shall notify the Board in writing of the move within 30 days after the move. A school moved to a new location is subject to inspection in accordance with 12 AAC 09.125(f).

General Information

APPLICATION PROCESSING:

The average time to process a paper application varies by program but can take several weeks from the date it is received in this office complete with all correct forms, supporting documents and appropriate fees paid. When the application is complete and correct, and all supporting documents have been received and all fees have been paid, the license will be issued. Start the process far enough in advance to allow for processing time. Applications are reviewed in order of receipt in our office, and walk-in customers should not expect immediate review.

LICENSE TERM:

There is no "inactive" status. If you choose not to renew your license, it will lapse. Licenses are issued for a two-year period and expire on August 31 of odd-numbered years, regardless of the date of issuance, except licenses issued within 90 days of the expiration date are issued to the next biennial expiration date. One renewal notice will be mailed at least 30 days before license expiration to the last known address of record.

PROFESSIONAL FITNESS QUESTIONS:

A "yes" response in the application does not mean your application will be denied. If you have responded "yes" to any professional fitness questions in the application, be sure to submit a signed and dated explanation, and the charging document and judgement.

DENIAL OF APPLICATION:

Please be aware that the denial of an application of licensure may be reported to any person, professional licensing board, federal, state, or local governmental agency, or other entity making a relevant inquiry or as may be required by law.

RANDOM AUDIT:

If your program requires continuing education, the Division will audit a percentage of the license renewals. If your license is randomly selected for audit, a letter will be sent with instructions to submit documentation as proof you satisfied the continuing competency requirements as stated on this renewal form. Licensees are randomly selected by computer and may be randomly selected as often as the computer program chooses. You must save your documents for at least four years so you can respond to audits.

ADDRESS OR NAME CHANGE:

In accordance with 12 AAC 02.900, it is the applicant's/licensee's responsibility to notify the Division, in writing, of changes of address or name. Name and address change notification forms are available on the Division's website. The address of record with the division will be used to send renewals and all other official notifications and correspondence. The name appearing on the license must be your current legal name.

CERTIFIED TRUE COPIES:

If any of the required documents will be issued under a former name, indicate on the application and submit marriage license and/or court documents that are notarized as a "certified true copy of the original document". To obtain a certified true copy, you must present the notary with the original document along with the photocopy. You must write, "I certify this is a true copy of the original document" and sign your name. The notary will compare the original document with the copy and then notarize your signature.

SOCIAL SECURITY NUMBERS:

AS 08.01.060 and 08.01.100 require that a U.S. Social Security Number be on file with the division before a professional license is issued or renewed for an individual. If you do not have a U.S. Social Security Number, please complete the Request for Exemption from Social Security Number Requirement form (#08-4372) located at *ProfessionalLicense.Alaska.Gov* or contact the division for a copy of the form. This form is required with every application if you do not have a U.S. Social Security Number.

PUBLIC INFORMATION:

Please be aware that all information on the application form will be available to the public, unless required to be kept confidential by state or federal law. Information about current licensees, including mailing addresses, is available on the division's website at *ProfessionalLicense.Alaska.Gov* under License Search.

ABANDONED APPLICATIONS:

Under 12 AAC 02.910, an application is considered abandoned when 12 months have elapsed since correspondence was last received from or on behalf of the applicant. An abandoned application is denied without prejudice. At the time of abandonment, the division will send notification to the last known address of the applicant, who has 30 days to submit a written request for a refund of biennial license and other fees paid. The application fee will not be refunded. If no request for refund is received within that timeframe, no refund will be issued, and all fees will be forfeited.

BUSINESS LICENSES:

The status of a professional license will directly impact the status of an associated business license. Renewal applications for business licenses are mailed separately. For more information about business licenses, (907) 465-2550 or *BusinessLicense.Alaska.Gov*

STALE DOCUMENTS:

Application forms, authorizations and verifications older than 12 months from the date the document was received by the division will be considered stale; the document must be resubmitted as appropriate before the application will be considered by the division or a licensing board. Application documents include the application documents and verifications of licensure from other licensing jurisdictions. (12 AAC 02.915)

PAYMENT OF CHILD SUPPORT:

If the Alaska Child Support Enforcement Division has determined that you are in arrears on child support, you may be issued a nonrenewable temporary license valid for 150 days. Contact Child Support Services at (907) 269-6900 to resolve payment issues.

- (3) a book or books on general anatomy, physiology, and hygiene.
- (b) The school shall provide each student with at least one board-approved textbook covering the subjects listed in 12 AAC 09.148.
- (c) The practical instructional area must have available the following equipment:
 - (1) a cabinet for instruments and linens;
 - (2) a towel container for soiled linens;
 - (3) a smock;
 - (4) terrycloth or disposable towels;
 - (5) manicuring materials, including orange wood sticks, finger bowls, steel pushers, emery boards, metal nail files, cuticle nippers, callus removers; moisturizing lotion, antibacterial soap, finger nail clippers, plastic spatulas, septic powder, cotton balls, cuticle cream, cuticle oil, cuticle solvent, supply trays, polish, tweezers, nail brushes, and chamois buffers;
 - (6) a manicuring table with adjustable lamp and two chairs;
 - (7) pedicure tubs;
 - (8) a manicure ventilation system;
 - (9) a paraffin wax machine;
 - (10) artificial nail supplies, including acetone, acrylic powder and liquid, dappen dishes, nail forms and tips, natural bristle brushes, fine and heavy grit files, small scissors, buffing blocks, primer, safety glasses and mask, adhesive, glue, three-way buffers, nail oil, professional electric fingernail drills and silk wraps;
 - (11) rubber or latex gloves.
 - (12) chemical agents and containers for sanitary purposes.
- (d) For every six or fewer students working at one time, the practical instructional area must have a wash basin with running hot and cold water.
