### **Registered Guide-Outfitter Application for Additional Species Instructions**

### Qualifications for additional species:

- 1. Currently licensed as a Registered Guide-Outfitter.
- 2. Been involved in a minimum of three harvests on guided hunts for each of the species requested.

The following must be received by the division before your Registered Guide-Outfitter Application for Additional Species can be reviewed:

#### 1. APPLICATION

A completed application, signed and notarized (#08-0015).

#### 2. VERIFICATION OF HARVESTS ON GUIDED HUNTS

Documentation reflecting that the applicant has been involved in a minimum of three harvests on guided hunts for each of the species requested. Documentation can be demonstrated by submitting the following:

- **A.** An affidavit signed by the registered guide-outfitter certifying that the registered guide-outfitter has been involved in a minimum of three harvests on guided hunts for that species (#08-0015a);
- **B.** A list of big game hunters that you have accompanied in the field on guided hunts(#08-0015b), with identification of the year(s) and the contracting guide-outfitter(s). Hunt records on file with the Division will be used to determine your qualification of the requested species.



I further agree to submit to questioning by the Board or any member thereof, and to substantiate any statements if desired by the Board.
