REAL ESTATE SALESPERSON APPLICATION BY ENDORSEMENT

Please read instructions before completing this application. Any portion of application that is not submitted may delay the issuance of your license.

APPLICATION PROCEDURES

The following items must be on file before you will be considered for Salesperson License by Endorsement:

- 1. A complete and notarized application. (12 AAC 64.059(c)(1)).
- 2. Payment of the required fees (12 AAC 64.059(c)(1) and 12 AAC 02.360(2)(9)):

Nonrefundable application fee: \$200.00 License fee: \$200.00 Recovery Fund fee: \$30.00 Total: \$430.00

- 3. Provide a License History, including License Status, from jurisdiction where you hold or have ever held a Real Estate License. At least one jurisdiction must reflect licensure at the Salesperson level, and that license must be current and active on the date your Alaska application is considered "complete". The License History information must be sent directly from another licensing authority to the Alaska Real Estate Commission LICENSE HISTORIES/CERTIFICATIONS CANNOT BE ACCEPTED DIRECTLY FROM APPLICANTS. 12 AAC 64.059 (c), (12 AAC 64.059 (c)4), 12 AAC 64.061 (b)(c)).
- 4. Submit the **original** exam score sheet showing proof of passing the "Alaska" portion of the Salesperson exam. Exam scores are <u>valid ONLY for six months from date of exam.</u> You <u>must</u> have a complete application filed with the Alaska Real Estate Commission prior to expiration of the exam scores. For information and the application for examination, contact Pearson VUE at 1-800-274-5992 or www.pearsonvue.com.(08.88.171(c), 08.88.263(1), 12 AAC 64.059(c)(2) and (3), and 12 AAC 64.060(e))
- 5. Provide evidence of completing a 6-hour course on Alaska's Real Estate Law. (12 AAC 64.059(c)(6); 12 AAC 64.063 (c)(7)). In accordance with 12 AAC 64.063(2), all real estate education courses used to qualify for initial licensure must have been completed within the 18 months immediately preceding the date of the application. For a list of approved schools go to: www.commerce.alaska.gov/occ/prec.htm. Education certificates are valid ONLY for 18 months from date course was completed.
- 6. Submission of proof of Salesperson prelicensing education equivalent to the 40 hours required in 12 AAC 64.063(c). Copies of your education certificates or a transcript is required. In accordance with 12 AAC 64.063(a)(2), these hours must have been completed within 24 months immediately proceeding the date of application. (Education topics listed in 12 AAC 64.063(c)(1) – (8)) are:

Licensee Relationships, disclosure and conflict of interest – 6 contact hours;

Forms of ownership, including role of community associations – 4 contact hours;

Property law, public and private rights and limitations – 4 contact hours;

Forms of conveyances and recording of documents – 4 contact hours;

Contracts and transaction documents, including resale certificates – 8 contact hours;

Financing instruments and accounting principals for community associations – 6 contact hours;

Alaska real state license law and Alaska landlord tenant law - 6 contact hours; and (see #5 above)

Federal fair housing and RESPA laws - 2 contact hour. (08.88.091(b), 12 AAC 64.059 (c)(5))

- 7. Completion of a written statement verifying you have worked as a Real Estate licensee, as your principle occupation, within the immediate six months proceeding the date of application. The statement is included as section C of the application form. To be eligible for endorsement, you must have within those six months been employed by or affiliated with a broker.
- 8. Supporting documentation for any "yes" answers. Supporting documents include the charging document and judgment for each criminal conviction. For any other "yes" answer, provide copies of court records, copies of license actions, and any other applicable documents. Additionally, provide your explanation on a separate sheet of paper labeled with your name, and signed by you; include full details, dates, locations, type of action, organizations or parties involved, and specific circumstances.

POST LICENSING EDUCATION

All new licensees are required to complete 30 hours of post-licensing education (PLE). This education must be completed within one year after the date of initial salesperson or broker licensure. This is in addition to the 20 hours of continuing education that you must complete to renew your license. After the required 30 hours of PLE is completed an Affidavit of Post Licensing Affidavit form (08-4326) **MUST** be submitted to the Real Estate Commission. Copies of all certificates of the completed education and appropriate fees must accompany the PLE Affidavit within 30 days after the 1 year period of initial licensure (AS 08.88.095) or the license will lapse. New licensees applying for licensure by endorsement who hold a active and valid real estate license in another state and have been licensed by that state for 1 year or more are **NOT** required to complete PLE (AS 08.88.263(3). Additional information about post-licensing requirements is available on the Commission web site in the Professional Licensing Section at www.commerce.alaska.gov/occ/.

GENERAL INFORMATION

In accordance with 12 AAC 02.900, a person licensed by the Real Estate Commission is required to maintain a current, valid mailing address on file with the division at all times.

- Please notify the division, in writing, should you have a change of address.
- In accordance with AS 08.88.321, the license certificate of a Broker must be displayed in the Broker's principle
 office.

RENEWAL INFORMATION

All licenses expire on January 31 of even-numbered years. Exception: Licenses issued within 90 days of the expiration date will be issued through the next biennium.

Continuing education is required at the time of renewal; refer to 12 AAC 64.500 for continuing education requirements.

SOCIAL SECURITY NUMBERS

In accordance with AS 08.01.060, the department is not authorized to issue a license to a natural person, unless the applicant's Social Security Number has been provided to the department. If you are a foreign citizen unable to obtain a United States Social Security Number, please contact the division for further instructions or obtain the Exception from SSN Requirement Form number 08-4372, from the division Web Site at: www.commerce.alaska.gov/occ/.

PAYMENT OF CHILD SUPPORT
