


Dear Ms. Katzke,

We have received your pre-qualification application for [REDACTED] to receive a tax credit under the Alaska Film Production Tax Credit program. After reviewing your materials, we are pre-qualifying your project for a tax credit up to [REDACTED]. Qualifying expenses incurred after [REDACTED] the date agreed upon by the film office and Affinityfilms, Inc. (per 3 AAC 188.020), will be eligible for the Alaska Film Production Tax Credit.

This approval does not guarantee the amount of tax credit that may be earned. After we receive the final application for the tax credit, along with required back-up and verification we will determine the actual tax credit. There are certain circumstances under which the Alaska Film Office may grant a larger tax credit which are detailed in 3 AAC 188.050(d).
