Dear Mr. Sharda,

We have received your pre-qualification application for [REDACTED] to receive a tax credit under the Alaska Film Production Tax Credit program. After reviewing your materials, we are approving your request to pre-qualify your project for a tax credit up to [REDACTED].
