We have received your pre-qualification application for [REDACTED] to receive a tax credit under the Alaska Film Production Tax Credit program. After reviewing your materials, we are pre-qualifying your project for a tax credit up to [REDACTED]. Qualifying expenses incurred after [REDACTED] the date agreed upon by the film office and FremantleMedia Australia PTY Ltd. (per 3 AAC 188.020), will be eligible for the Alaska Film Production Tax Credit.
