We have received your pre-qualification application for [REDACTED] to receive a tax credit under the Alaska Film Production Tax Credit program. After reviewing your materials, we are pre-qualifying your project for a tax credit of up to [REDACTED]. Qualifying expenses incurred after [REDACTED] (the date agreed upon by the film office and Original Productions - per 3 AAC 188.020), will be eligible for the Alaska Film Production Tax Credit.

This approval does not guarantee the amount of tax credit that may be earned. After we receive the final application for the tax credit and the required verification materials we will determine the actual tax credit amount. The Alaska Film Office may award a larger or smaller tax credit, depending on circumstances. Regulations regarding the award of tax credits are detailed in 3 AAC 188.050.
