

Dear Mr. Welch:

We have received your pre-qualification application for [REDACTED] to receive a tax credit under Alaska's film production incentives program. After reviewing your treatment, budget and application, we are approving your request to pre-qualify your project for a tax credit.

This approval does not guarantee the amount of tax credit that may be earned. After we receive your final application along with proper back-up and verification from an Alaskan CPA firm, we can determine the actual tax credit amount. We acknowledge you estimate a potential [REDACTED] in tax credit certification.

It is important to note that the Alaska Film Incentives Tax Credit is finalizing the regulations approval process. The revised version of the regulations has been submitted to the Lieutenant Governor's Office, for his signature. Any producer incurring expenses while the regulations are still being vetted does so under the assumed risk that expenses believed to qualify for a tax credit may not, and, conversely, possible increases of eligible expenses could also occur.

We will be updating our website (<http://www.alaskafilm.org/bulletinboard.htm>) this week with the anticipated final version of the regulations. The regulations will be formally adopted, barring no changes, 30 days after the Lt. Governor's signature.

Thank you for your application and we thank you for choosing to film in Alaska.
