within the last twelve months would reduce the policyholders surplus by more than 50%.

WHEREAS, The 2000 Annual Statement of **PENN TREATY NETWORK AMERICA INSURANCE COMPANY** shows that the policyholders' surplus has declined by more than fifty percent from the prior year.

WHEREAS, 3 ACC 21.520 states that when the director determines that an insurer is impaired or in imminent danger of becoming impaired, the director may order an insurer to reduce, suspend, or limit the volume of business being accepted or renewed.

IT IS HEREBY ORDERED, pursuant to the provision of 3 ACC 21.520 that **PENN TREATY NETWORK AMERICA INSURANCE COMPANY** shall suspend business being accepted from the State of Alaska for a period of one year unless terminated sooner as permitted by statute.


