STIPULATED AGREEMENT AND ORDER

The Alaska Department of Commerce, Community and Economic Development, Division of Insurance (Division) and **ROSE ANN LAU (LAU)** the producer in this case, stipulate and agree to the following:

I. BACKGROUND

A. On January 26, 2024, the Division received an application for an Insurance Producer license to transact the business of Life authority for LAU, domiciled in the State of Alaska. The application was processed on February 9, 2024, and the Division issued resident license number

3002945436. This license has an expiration date of November 30 of odd numbered years.

- B. In the initial application, LAU's responded negatively to question 1A, indicating no misdemeanor convictions to report to the Division.
- C. LAU's background history report from the Department of Public Safety was returned to the Division and indicated LAU was convicted of a misdemeanor effective June 10, 2007.
- D. LAU incorrectly responded negatively to background question 1A at initial application indicating no misdemeanor conviction to report to the Division, providing inaccurate information at initial application.

II. TERMS OF AGREEMENT

A. LAU was in violation for failing to report her misdemeanor to the Division which subjects LAU to civil penalties. Alaska Statute (AS) 21.27.440(a) provides that "in addition to any other penalties provided by law, a person that the director (director) determines under AS 21.06.170-21.06.240 has violated the provisions of this chapter is subject to (1) a civil penalty equal to the compensation promised, paid, or to be paid, directly or indirectly, to a person in regard to each violation; (2) either a civil penalty of not more than \$10,000 for each violation or a civil penalty of not more than \$25,000 for each violation if the director determines that the person willfully violated the provisions of this chapter; and (3) denial, nonrenewal, suspension, or revocation of a license." The director has the

latitude to impose civil penalties against a person who has violated Alaska's insurance laws.

- B. AS 21.27.020(a) provides: "For the protection of the people of this state, the director may not issue or renew a license except in compliance with this chapter and not issue a license to a person, or to be exercised by a person, found by the director to be untrustworthy, incompetent, or who has not established to the satisfaction of the director that the person is qualified under this chapter."
- C. AS 21.27.020(b)(4) provides: "To qualify for issuance or renewal of an individual license, an applicant or licensee shall (4) be a trustworthy person."
- D. AS 21.27.040(a) states that "(a) Application for a license shall be made to the director upon forms prescribed by the director. As a part of or in connection with the application, the applicant shall furnish information concerning the applicant's identity, personal history, experience, business record, purposes, and other pertinent facts that the director may reasonably require. The applicant shall declare, subject to penalty of denial, nonrenewal, suspension, or revocation of a license issued by the director, that the statements made in or in connection with the application are true, correct, and complete to the best of the applicant's knowledge and belief…"
