

NOTICE OF PROPOSED CHANGES ON LONG-TERM CARE INSURANCE  
IN THE REGULATIONS OF THE DIVISION OF INSURANCE

The Division of Insurance proposes to adopt regulation changes in 3 AAC 28 of the Alaska Administrative Code, dealing with long-term care insurance, including the following:

- (1) 3 AAC 28 is proposed to be changed as follows: A new article regarding long-term care insurance is proposed to be added, including policy standards, filing and form requirements, disclosure requirements, and other topics related to long-term care insurance.

You may comment on the proposed regulation changes, including the potential costs to private persons of complying with the proposed changes, by submitting written comments to Division of Insurance; Attention: Jackson Willard; P.O. Box 110805, Juneau, Alaska 99811; or by fax to (907) 465-3422, and by electronic mail at [insurance@alaska.gov](mailto:insurance@alaska.gov). Comments may also be submitted through the Alaska Online Public Notice System by accessing this notice on the system and using the comment link. The comments must be received not later than 5:00 p.m. Alaskan time on September 24, 2021.

You may provide oral comments relevant to the proposed action **via telephone** at the hearing to be held on September 15, 2021 **by calling 1-800-315-6338 and using Access Code: 42070#**. **Due to public health and safety concerns associated with the COVID – 19 pandemic, there will not be in-person attendance provided at the hearing site, so please prepare to share your oral comments by telephone only.** The hearing is scheduled from 2:00 p.m. to 3:00 p.m. and priority will be given to commenters on the line before the beginning of the hearing. The hearing may be extended to accommodate those on the line before 3:00 p.m. who did not have an opportunity to comment. Before the start of the hearing, the Division of Insurance may limit the time allotted for each person providing oral testimony, as reasonably necessary to conclude the hearing in the time provided.

You may submit written questions relevant to the proposed action to Jackson Willard by email at [jackson.willard@alaska.gov](mailto:jackson.willard@alaska.gov). The questions must be received at least 10 days before the end of the public comment period. The Division of Insurance will aggregate its response to substantially similar questions and make the questions and responses available on the Alaska Online Public Notice System and the Division's website.

After the public comment period ends, the Division of Insurance will either adopt the proposed regulation changes or other provisions dealing with the same subject, without further notice, or decide to take no action. The language of the final regulation may be different from that of the proposed regulation. You should comment during the time allowed if your interests could be affected.
