ACCUSATION AND FINAL ORDER

Lori Wing-Heier, Director of the Division of Insurance (Division), Department of Commerce, Community, and Economic Development (DCCED), State of Alaska, states the issues on which the accusation is based as follows:

- On November 27, 2023, JOHN JAMES POWTER (POWTER),
 domiciled in the State of Texas applied for an Insurance Producer license
 with the Division to conduct insurance business in the State of Alaska.
- Upon review of the application, POWTER responded negatively to background question 2, indicating no administrative actions to report to the State of Alaska.

- 3. The Producer Database and the Attachment Warehouse reflects administrative actions were taken against POWTER in the State of Wisconsin in effect November 2, 2000, in the State of Maine in effect November 16, 2000, and in the State of Indiana in effect October 2, 2008.
 POWTER failed to disclose his administrative actions to the Division and provided inaccurate information on his application.
- 4. On November 30, 2023, correspondence was provided to POWTER informing of his failure to respond accurately to a background question regarding administrative actions. The Division provided POWTER the opportunity to voluntarily withdraw the application and provide a new, complete, and accurate application within 30 days. No response was received.
- 5. Alaska Statute 21.27.040(a) states that "(a) Application for a license shall be made to the director upon forms prescribed by the director. As a part of or in connection with the application, the applicant shall furnish information concerning the applicant's identity, personal history, experience, business record, purposes, and other pertinent facts that the director may reasonably require. The applicant shall declare, subject to penalty of denial, nonrenewal, suspension, or revocation of a license issued by the director, that the statements made in or in connection with the application are true, correct, and complete to the best of the applicant's knowledge and belief…"
